Major Problems

Earlier this year, a sequence of events led Joanne Beard and Sims Lawson to resign as President and Treasurer, respectively, of the Association and as At-large Directors.

Bob Chase has agreed to serve as President and Karen Heim-Baugh has agreed to serve as Treasurer until a Special Meeting of the Board of Directors.

Joanne and Sims turned over all of their historical files to Bob and Karen in early March.

In reviewing the financial records, it was determined that the board needed professional help in understanding where we were. Fortunately, Bob Vogt, a CPA, had been elected as an At-large Director in June and he agreed to take that daunting task. He completed his work in late April

and identified a number of concerns regarding spending and lack of documentation.

The Board also has identified issues related to whether Life Member dues and Bible Project donations have been properly handled.

The directors and officers of the Association are rightly dismayed that there are problems. They are in the process of discussing what can be done to remedy the situation and what must be done to ensure that we do not have these problems in the future.

In addition, we continue to have problems with the membership database and in delivering expected materials in a timely fashion. The board also is addressing this, as it too is unacceptable.

Major Changes

The Board of Directors has been meeting on-line since late March and has instituted a number of changes in how the association is operated. More details will be presented and discussed at the Annual Meeting on June 28th.

Two At-large Directors have been elected to fill the positions vacated by Joanne and Sims. The two are: Hank Voegtle, an attorney from Dallas, Texas, and Chuck Jones, an expert on United Methodist polity and the GCUMM from Orlando, Florida. Four director positions will be filled at the June meeting. Nominations should be sent to: nominations@naums.org with a copy of a re-

sume.

A Chair of Finance has been added, with the Finance Committee tasked with developing guidelines and procedures for spending and travel expenses, developing budgets, and approving expenditures.

A Membership Secretary will soon be added, with the Membership Committee tasked with creating and maintaining the membership database, entering data received from Nashville, and handling orders for merchandise (patches, shirts and Wyatt prints) received from members.

A Bylaws Committee is looking at the bylaws for possibly significant changes to be recommended.

During the meeting the Board of Directors will report on the issues discussed elsewhere in this newsletter, four At-large Directors will be elected, changes to the Bylaws will be discussed and other business will be handled. The slate of nominees, changes to the bylaws and the recommended budget will be posted to the web site as early in June as they are available. The current bylaws authorize proxy voting. If you want to give your vote to someone,

please review the information on the web site to insure an informed vote.

You may recall that we announced a change to biennial member meetings last year. We discovered that Tennessee law requires an annual meeting of members. We're sorry for the confusion and the delayed notice.

The Board of Directors will be meeting at the same location on Friday and Saturday, June 27 and 28, 2003, (and possibly Sunday the 29th) beginning at 9:00 A.M. CDT. There may be some issues that the board will discuss in private, but the board meetings will otherwise be open to all members.
